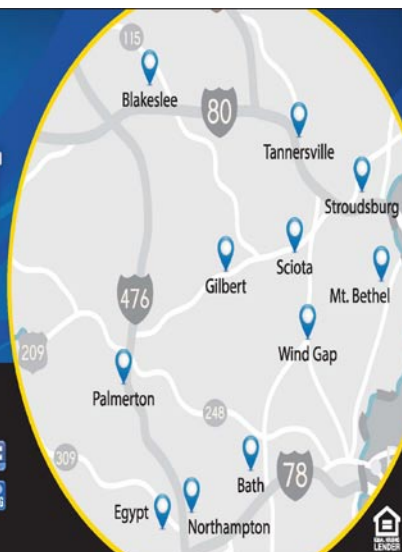

Highlighting Our Work for the Lehigh Valley and the Poconos

This week, I hosted an event in Bethlehem Township to highlight the work my team and I have accomplished during our first year serving the Lehigh Valley and the Poconos. Constituents who have worked with my office were in attendance to share how our team helped resolve issues involving federal agencies. Whether it's helping to acquire a Bronze Star for an American hero, retrieving money that was owed to local residents and organizations, or stepping in to assist with immigration and passports, my priority will always be making sure you have access to the highest quality constituent services.

Over the past year, my team has worked every day to help residents cut through red tape, solve problems with federal agencies, and access the support they deserve. Since taking office, we have resolved more than 5,500 constituent cases, helped return over \$10.3 million to families across our region, and responded to more than 120,000 calls, emails, and letters. We've also opened four district offices, participated in over 800 community events, meetings, and town halls, and advanced a bipartisan legislative agenda by introducing 10 bills and cosponsoring 127 pieces of legislation.

We also discussed the progress we've made on local priorities, including securing over \$1.7 million in Community Project Funding to support the construction of a new firehouse in Alburtis and accessibility improvements in Portland. These investments are about making sure our communities have the resources they need and that your tax dollars are working for you.
