PEN ARGYL AREA SCHOOL DISTRICT RESIDENTS

The Pen Argyl Area School District is offering a property tax rebate program. You may qualify if:

1. You have owned and occupied your home during the period for which you are claiming a rebate. Rebates are granted for your primary residence only; and
2. (a) You or your spouse (if living with you) were 65 years or older as of December 31, 2023; or
 - (b) You were a widow or widower during all or part of 2023 and were 50 years old or older as of December 31, 2023; or
 - (c) You were permanently disabled during all or part of 2023, and you were unable to work because of your medically determined physical or mental disability which is expected to continue indefinitely; and
3. Your total annual income, including the income of a spouse residing with you, was \$35,000 or less in 2023. (IMPORTANT: only report 50% of your Railroad Retirement benefits and 50% of Federal Social Security Act benefits); and
4. 2023/24 Pen Argyl School District Real Estate Taxes were paid in full.
5. Only one member of your household may file a claim.
6. Delinquent taxes DO NOT QUALIFY.

The deadline for filing an application is June 30, 2024. Applications are available at the Pen Argyl Area School District Office, or call the District Office at (610) 863-3191.
