## Delaware Water Gap Could Be On National Register of Historic Places for Native American Cultural

Great News our entire Delaware Water Gap is likely eligible to be listed in the National Register of Historic Places for Native American cultural reasons!

We are one step closer to an Environmental Impact Statement/Study thanks to the Federally Recognized Native American Tribes - Lenape. Good is coming out of this horrible situation with the NJDOT.

The DWG has played and continues to play an important role in the lives of Native American tribes, Mt. Tammany represents a contributing element to an as yet undefined Delaware Water Gap Traditional Cultural Property (DWGTC). Based on recent consultation with Tribal Nations. The DWGTC will likely be determined eligible for inclusion in the National Register based on its association with the cultural practices and traditions associated with the Delaware Tribe, the Delaware Nation and the Stockbridge-Munsee Community. - From the September 2021 NJDOT contract for the current Archaeological Phase 1B Survey and Report due out at the end of the year.

What type of project must be scrutinized over historical or cultural impact concerns? Those that may alter, directly or indirectly, any of the characteristics of a historic property that qualify the property for inclusion in the National Register of Historic Places in a manner that would diminish the integrity of the property's location, design, setting, materials, workmanship, feeling, or association.
