Strengthening Invasion of Privacy Legislation

After meeting with a woman who shared her harrowing experience of being unknowingly recorded by a man while she was using a public restroom, I introduced legislation that would toughen the penalties for invasion of privacy and require offenders to delete any recordings associated with their convictions.

Despite the repugnant act, the perpetrator was only charged with a handful of misdemeanors. To add to the trauma and embarrassment, there was no legal requirement for him to delete the recording.

House Bill 2503 would address this issue through two main objectives. First, it would increase the grading of invasion of privacy offenses. Second, the bill would mandate any individual convicted of invasion of privacy must delete or destroy any photograph, videotape, electronic depiction, film, record or other recording associated with the conviction.

Individuals who commit such heinous and psychologically damaging crimes must face consequences that reflect the seriousness of their actions. We must ensure offenders are prohibited from retaining any recordings obtained through these abhorrent acts. We owe this to the victims, who have had their sense of trust and personal safety violated.

This legislation is a crucial step toward ensuring Pennsylvania's laws adequately protect the privacy and dignity of our residents. House Bill 2503 was referred to the House Judiciary Committee for consideration.
