**Real ID Update:**  
New TSA Identity Verification Fee

If you plan to fly domestically and do not have a REAL ID-compliant driver's license or another acceptable form of identification, there is an important update to keep in mind. Travelers who arrive at the airport without proper ID may now need to pay a \$45 identity verification fee through TSA's ConfirmID process.

To avoid delays, extra costs, and stress at the airport, be sure to travel with a REAL ID, passport, or another TSA-accepted form of identification. If you're unsure whether your license is REAL ID-compliant, check with PennDOT or your state Department of Motor Vehicles.
